RACE 1 (R534) CLASS 5 – 1100m(str) – EUPHRATES HANDICAP

GLORY BETTING (App Z Khairil) reared as the gates were released and lost ground.

KIWI MAESTRO (S Sandana) and OZZY (TM Wan) were slow to begin.

Post-race veterinary examinations of OZZY and GLORY BETTING revealed no obvious abnormality.

RACE 2 (R535) CLASS 5 – 1800m(sc) – WHO KNOWS HANDICAP

RIEDEL which was up 19kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

HAPPY SURPRISER (App AM Aizat) was examined by the Club Veterinary Surgeon behind the barriers and passed fit to start.

A post-race veterinary examination of MARIO ATTILA (R Olechea) revealed no obvious abnormality.

The Club Veterinary Surgeon reported that RIEDEL (TM Wan) returned having cast its near hind plate.

RACE 3 (R536) CLASS 5 - 1400m(sc) - ON STAGE HANDICAP

CONQUISTADOR (App AM Aizat) which was over-racing, had to be steadied at the 850M when RACING MAN (SS Vanan) rolled in.

App AM Aizat, the rider of CONQUISTADOR dropped his whip at the 300M and was advised that a repetition may lead to action being taken against him.

Jockey S Sandana, the rider of PROPITIONS GOLD reported that his mount was making respiratory noises. A post-race veterinary examination of PROPITIONS GOLD revealed that the gelding had returned lame off fore and as such, will be required to pass a test (1000m/vet) before being declared to race again.

RACE 4 (R537) CLASS 5 – 1400m (sc) – LITTLE PAPPA HANDICAP

AUDACIOUS, a course scratching as it had a bruised off hind fetlock, will be required to pass a veterinary examination before being declared to race again.

The Stewards questioned Jockey M Yusri, the rider of ADMIRAL DELIGHT as to his whip use on the gelding in the straight and he was warned that he must ensure that he uses his whip in an effective manner in future.

RACE 5 (R538) CLASS 5 –1400m (sc) – ONE THREE ONE HANDICAP

Shortly after the start, DAWN PROSPECT (KT Cheng) clipped the heels of VALENTINE BABY (R Olechea).

Racing to the 1200M, CLASSIC ARROW (App KC Tham) was checked and shifted out, forcing TAVAN BOGD (F Yap) wider on the track

TAVAN BOGD which raced poorly, will be required to pass a test (1000m/vet) before being declared to race again.

Post-race veterinary examinations of CLASSIC ARROW and TAVAN BOGD revealed no obvious abnormality.

The Stewards opened an Inquiry into the performance of CLASSIC ARROW and after taking evidence from App KC Tham, the rider and Trainer Kevin Coetzee, the trainer of the gelding, the Inquiry was adjourned to a date to be fixed.

The Stewards questioned Jockey F Yap, the rider of TAVAN BOGD as to the gelding's poor performance today. He stated that he was inconvenienced shortly after the start by EL COMANDANTE (App KC Wong). He further stated that racing to the 1200M, he was forced off the track when CLASSIC ARROW shifted out abruptly and he had to check TAVAN BOGD back onto the rails. He further stated that the gelding failed to respond to his riding throughout the race and was very disappointing.

The saddle on BAZINGA (S Sandana) slipped sideways during the running.

The Stewards adjourned an Inquiry into Jockey WK Yan's ride on ONLY YOU to a date to be fixed, as Jockey WK Yan had left the course.

The Club Veterinary Surgeon reported that Q NINE MYSTIC (Y Aify) returned lame off fore and as such, will be required to pass a test (1000m/vet) before being declared to race again.

BEAUTIFUL CHOICE (Lou Ho) which stood when the gates were released and lost considerable ground, will be required to pass one starting stall test before being declared to race again.

ALL SERENE threw its head back shortly after the start, inconveniencing App SU Lim for a short distance.

SACRED CITY (F Yap) was slow to begin.

At about the 1000M, RAPID APPROACH (J De Souza) rolled out, brushed ALL SERENE (App SU Lim), taking DROGBA (App S Saddam) wider on the track. Shortly after this incident, SOUL COMMANDER (S Sandana) rolled out and inconvenienced RAPID APPROACH.

Addendum: RACE 2 (R529) CLASS 5 – 1100m(str) – TIEN AN MUN HANDICAP PERAK LATE APRIL MEETING – 1st DAY, SATURDAY, 23rd APRIL 2016

App AK Lim, the rider of MARCO POLO approached the Stewards today with a request to defer the commencement date of his suspension. The Stewards acting under the provision of MRA Rule 48(5) acceded to his request and his suspension of two (2) Malaysian race days will commence on Monday, 2nd May 2016 and to expire on Saturday, 14th May 2016, both dates inclusive.

RACE 4 (R531) CLASS 4 – 1600m (lc) – SUSPICION HANDICAP PERAK LATE APRIL MEETING – 1st DAY, SATURDAY, 23rd APRIL 2016

The Stewards today (Sunday, 24th April 2016) resumed the Inquiry into the riding and handling of LOVE ME (Y Aify). Further evidence were taken from Jockey Y Aify and Trainer Evert Van Breukelen. The Stewards noted Trainer Evert Van Breukelen's evidence and his instructions he had given to Jockey Y Aify to give LOVE ME a clear run in the race.

After taking all evidence into consideration and reviewing the video of the race, Jockey Y Aify was found guilty to a charge under MRA Rule 44(10) in that from the 500M when he had a clear run, the Stewards were not satisfied as to why he shifted to the inside of THE THINKER (App AM Aizat) at that stage, when there was a clear run to the outside of THE THINKER.

In assessing the penalty, the Stewards took into consideration Jockey Y Aify's disciplinary record and mitigating factors. Jockey Y Aify was suspended from riding in races for a period six (6) months with effect from Monday, 25th April 2016 and to expire on Monday, 24th October 2016, both dates inclusive. In addition, he was also fined a sum of RM10,000/-. He was informed of his right of appeal (1.00pm).

Jockey Y Aify subsequently exercised his right of appeal and applied for a stay of sentence which was granted. (5.45pm).
